

**AN ORDINANCE AMENDING SECTION 206.07 OF THE CODIFIED ORDINANCES FOR THE PURPOSE OF UPDATING SPECIFIC INFORMATION.**

WHEREAS, this Council believes that transparency is of paramount importance in its governance of the City; and

WHEREAS, citizens are entitled to notice of the time and place of all regular Council meetings; and

WHEREAS, citizens are also entitled to notice of the time, place, and purpose of special Council meetings once scheduled; and

WHEREAS, the Codified Ordinances' Council meeting notification provision is outdated and must be updated.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hudson, Summit County, Ohio as follows:

Section 1. That Section 206.07 of the Codified Ordinances of the City of Hudson be amended as follows, with additions in **bold and underlined** and deletions being ~~stricken and underlined~~:

**206.07 ASCERTAINING NOTIFICATION.**

Any person may ascertain the time and place of all then-known regular meetings, the time, place, and purposes of all then-known special meetings, and whether the available agenda of any future meeting states that any specific type of public business, identified by such person, is to be discussed at such meeting, by:

- (a) ~~writing, to: Clerk of Council, City of Hudson Municipal Services Center, 115 Executive Parkway, Suite 400, Hudson, OH 44236-1693~~
- (b) telephoning the office of **the** Clerk of Council, ~~(during its normal business hours), at 330-342-1353 or 330-650-1799.~~ **or**
- (c) consulting the City's website, **where the time, date, and purpose, as applicable, shall be posted** ([www.hudson.oh.us](http://www.hudson.oh.us)).

Section 2. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Ordinance.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance shall be in full force and effect from and after the earliest period allowed by law.
