**RESOLUTION 2026-**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA FORMALLY RECOGNIZING THE CITY'S ONGOING RELATIONSHIP WITH THE GREENWAY WOMEN'S GOLF ASSOCIATION, INC., THE CORAL GABLES WOMEN'S GOLF AND BRIDGE ASSOCIATION, INC., AND GRANADA GOLF ASSOCIATION, INC., DIRECTING STAFF TO CONTINUE TO SET ASIDE CERTAIN TEE-TIMES FOR MEMBERS OF THOSE ASSOCIATIONS**

**WHEREAS**, the Greenway Women's Golf Association, Inc., Coral Gables Women's Golf and Bridge Association, Inc., and Granada Golf Association, Inc. are non-profits in South Florida dedicated to promoting golf, social activities, and organizing local tournaments; and

**WHEREAS**, these organizations have served the community for decades, Greenway Women's Golf Association for over sixty years, the Coral Gables Women's Golf and Bridge Association for over a century, and Granada Golf Association, Inc. for over sixty years as well; and

**WHEREAS**, the City Commission wishes to acknowledge these long-standing community groups and formalize the City's practice of providing protected weekly tee times for these groups; and

**WHEREAS**, currently, the City provides a protected set of tee times from 8:00-9:00 A.M. on Mondays for those approximately fifty-five (55) members of the Greenway Women's Golf Association; and

**WHEREAS**, currently, the City provides a protected set of tee times from 8:00-8:30 A.M. on Fridays for those approximately thirty-five (35) members of the Coral Gables Women's Golf and Bridge Association; and

**WHEREAS**, currently, the City provides a protected set of tee times from 8:10-9:10 A.M. on Saturdays and 8:30 – 9:00 A.M. on Sundays for those approximately sixty (60) members of the Granada Golf Association; and

**WHEREAS**, the City Commission wishes to formally direct staff to reserve and protect those tee times outlined above to offer continuity, stability, and fairness for the established community groups utilizing Granda Golf Course; and

**WHEREAS**, these dates, times, and protected hours for the Greenway Women's Golf Association, Inc., Coral Gables Women's Golf and Bridge Association, Inc., and Granada Golf Association, Inc., shall not be amended or removed without further direction

of the City Commission; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission directs staff to ensure that the traditional protected tee times of the Greenway Women’s Golf Association Inc., Monday from 8-9 A.M., the Coral Gables Women’s Golf and Bridge Association, Inc., Fridays from 8-8:30 A.M., and the Granada Golf Association, Inc. from 8:10- 9:10 A.M. Saturdays and 8:30-9:00 A.M. on Sundays continue to be honored and that no amendment to those protected times shall be made without further direction of the City Commission.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
