He also provided an update on the ongoing audit to identify discrepancies reported by the previous auditor. No issues were identified in the 2023 review, and the audit has now progressed to 2024 records. Discussion was held regarding contacting the previous auditor, as he notified the County of the discrepancy but did not provide guidance or assistance in resolving or locating the issue. It was noted that contingency funds have not yet been utilized; however, the County is approaching the point where use of those funds may become necessary, which could result in a tighter budget for the remainder of the fiscal year.


