**ISSUE:** The City Commission will consider the selection of a City Manager.

**ANALYSIS:** On December 15, 2025, the City Commission approved the desired characteristics and job description for the new City Manager. The position was advertised on December 16, 2025 with a deadline for submitting resumes of Friday, January 16, 2026. Thirteen applications were received and were distributed to the City Commission at the January 20, 2026 regular meeting. Selection of three (3) finalists were made on Monday, February 2, 2026 and interviews of the three finalists were held on Wednesday, February 11. Following the interviews, it was decided by the City Commission to delay the decision of the selecting the next City Manager until the next regularly scheduled meeting on February 16, 2026.

Former City Manager Bobby Green has been assisting the Commission with the recruitment process and will make a brief presentation prior to the City Commission's discussion and selection of a finalist for the City Manager position.

**STAFF RECOMMENDATION:** Select a finalist for the City Manager position and direct the Mayor and City Attorney to negotiate an employment agreement with the finalist.
