- Direct nexus with other priorities in the Work Program, including Housing Element Update and draft Environmental Justice Element

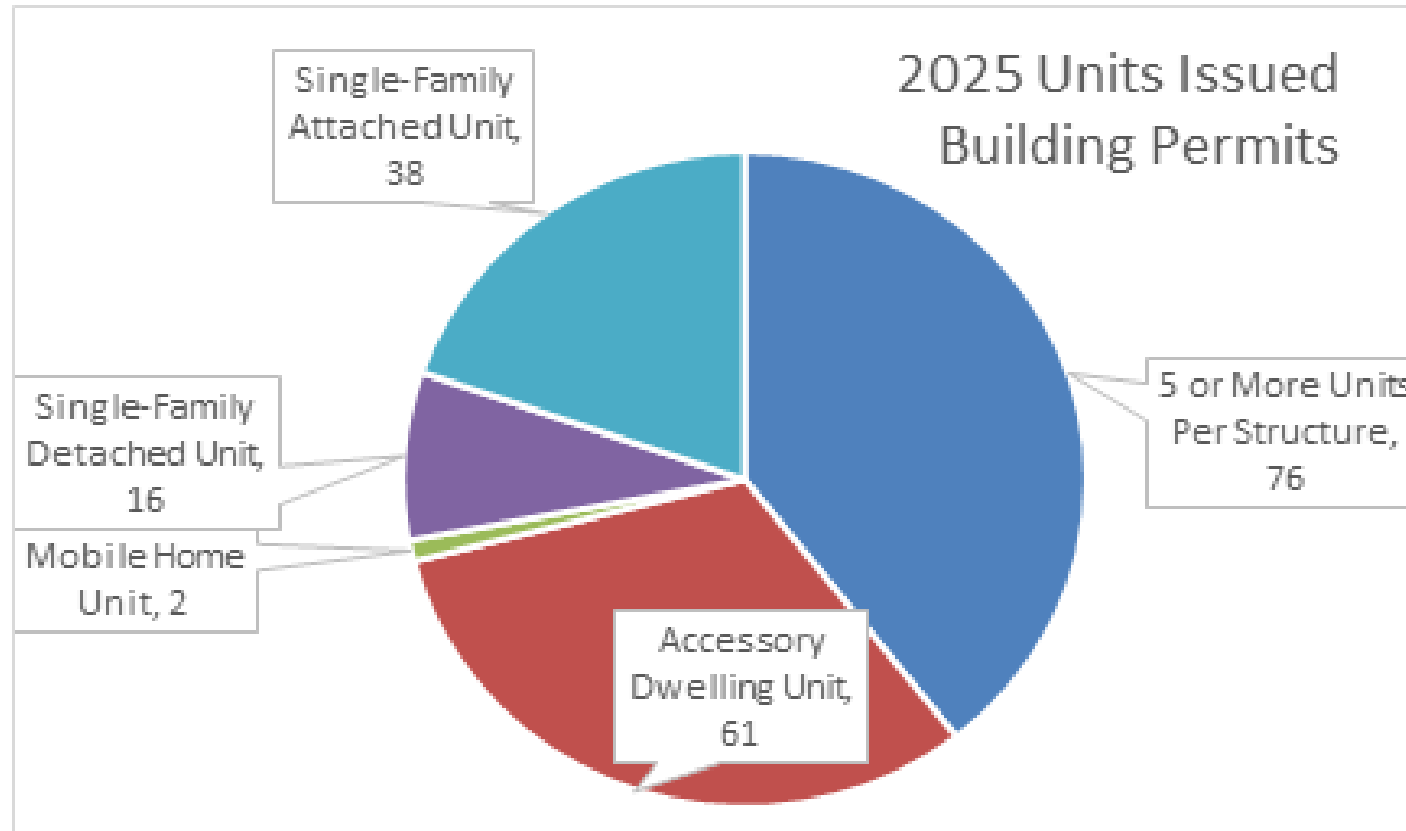

- Additional Funding Sources

    - General Plan Implementation - \$373,787

  - FY26 and FY27 – Measure AA Funds
    - Housing Element Implementation - \$650,000
    - Battery Energy Storage System Ordinance Development - \$100,000
    - Fire Preparedness/Home Hardening - \$100,000
  - FY27 - Requested Augmentations
    - General Plan Updates – \$300,000
