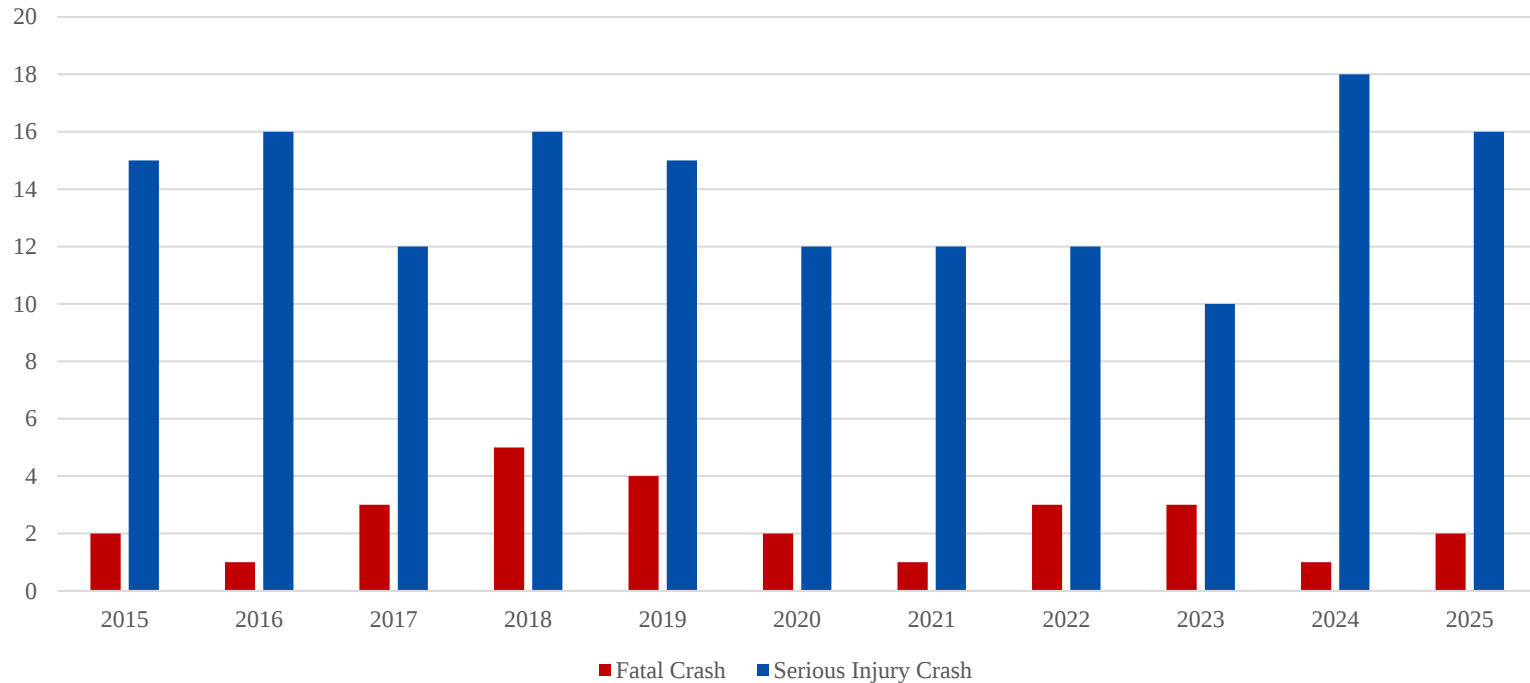

Rockville Fatal and Serious Injury Crashes 2015-2025



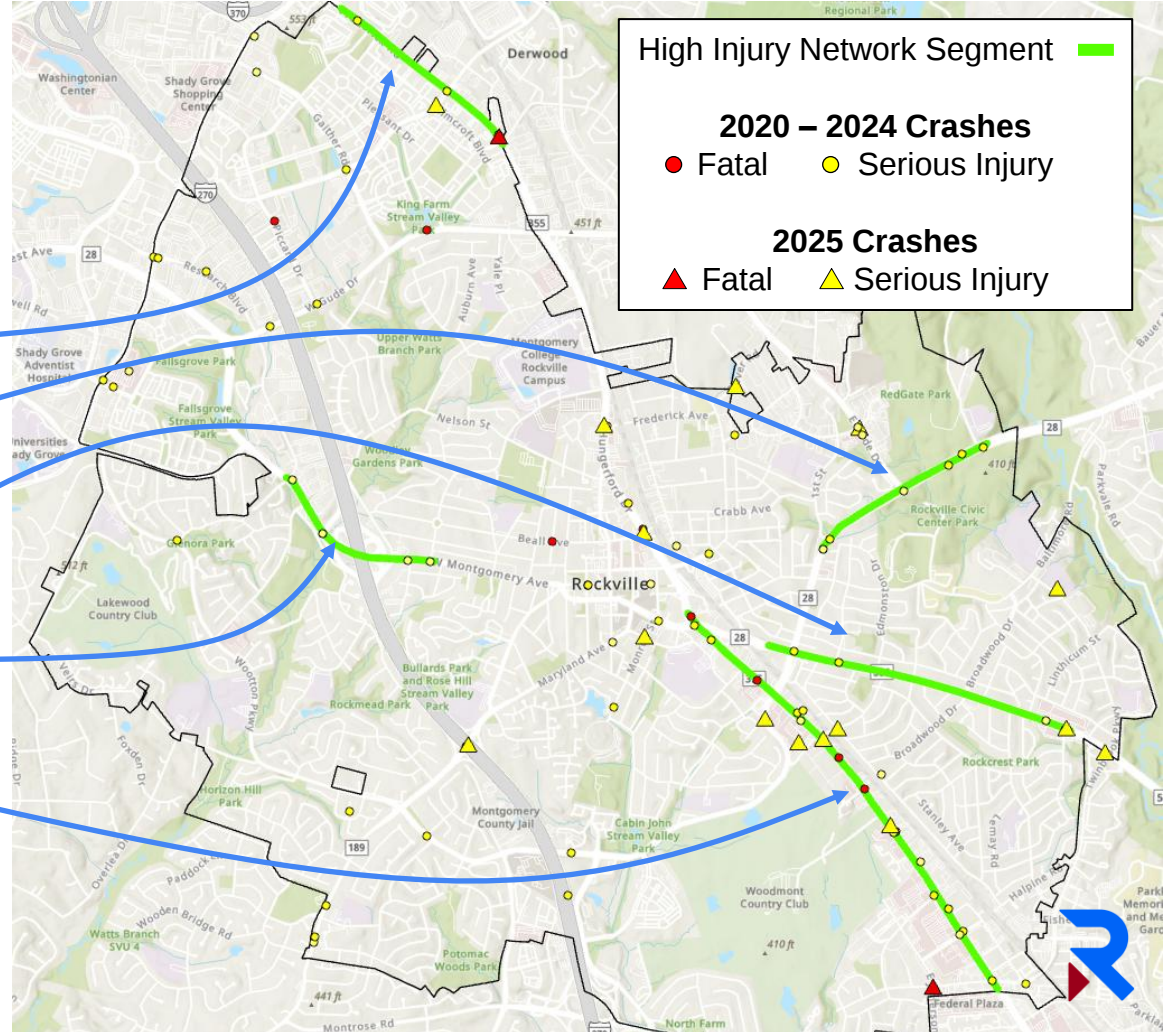
High Injury Network

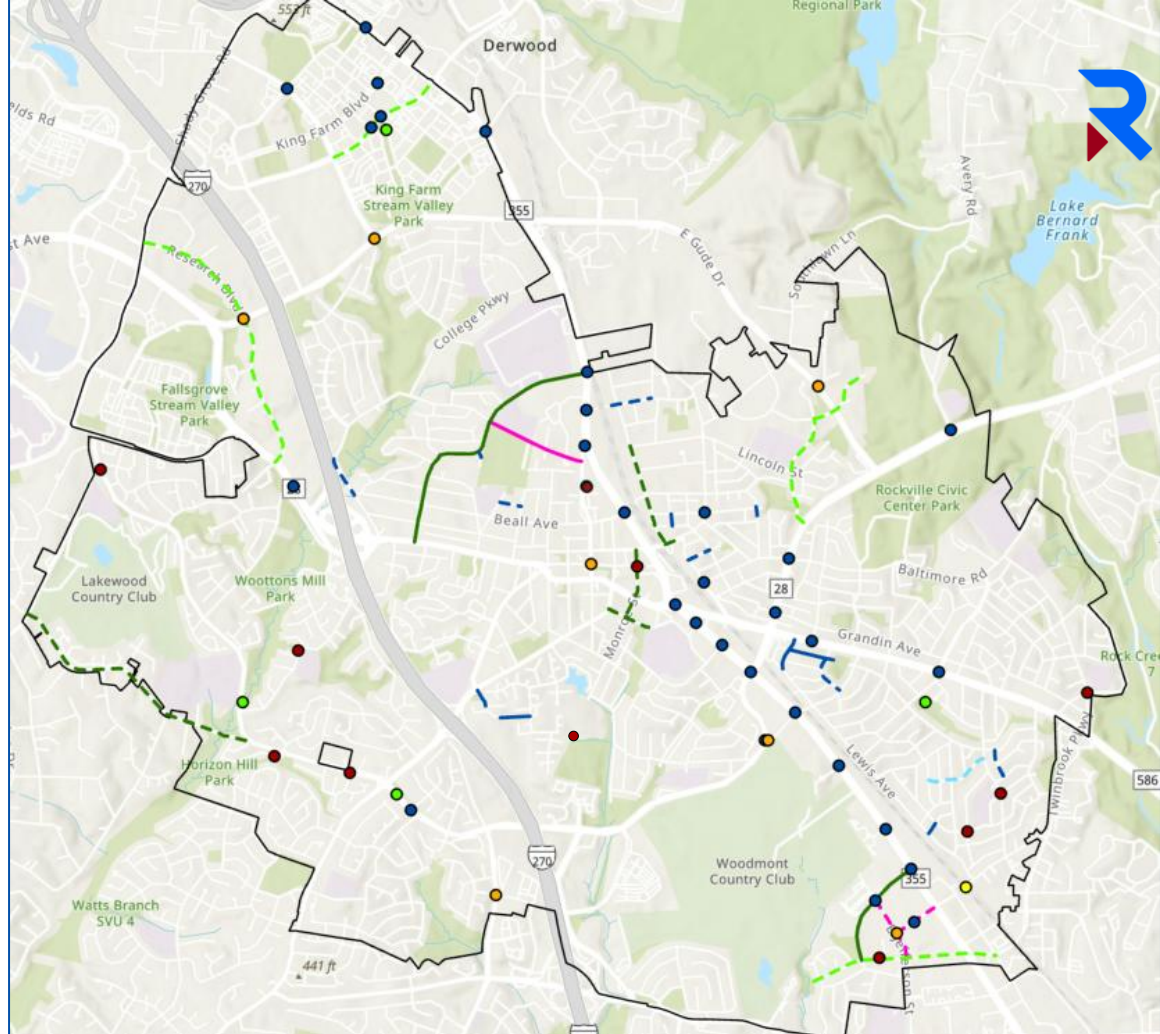

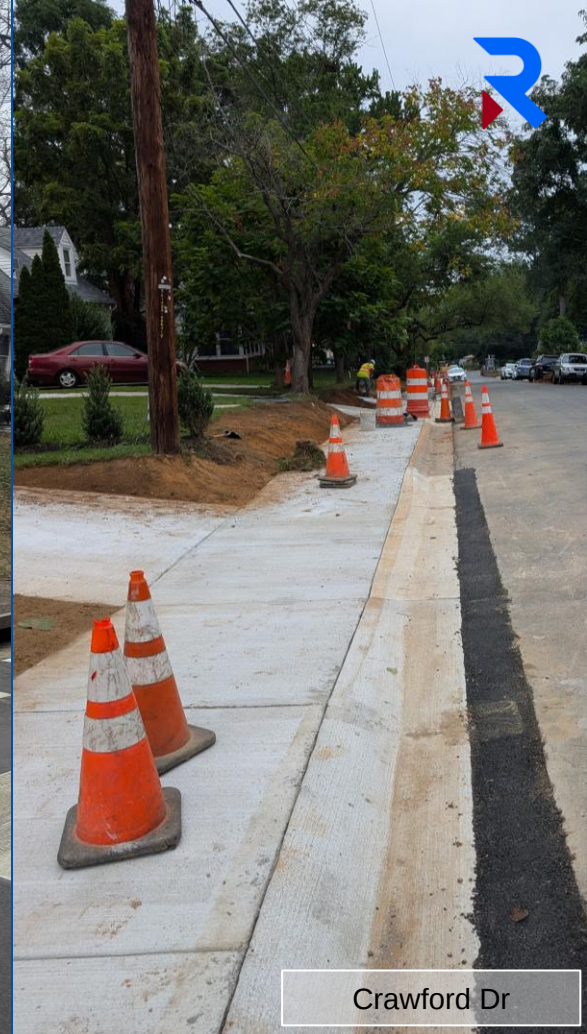

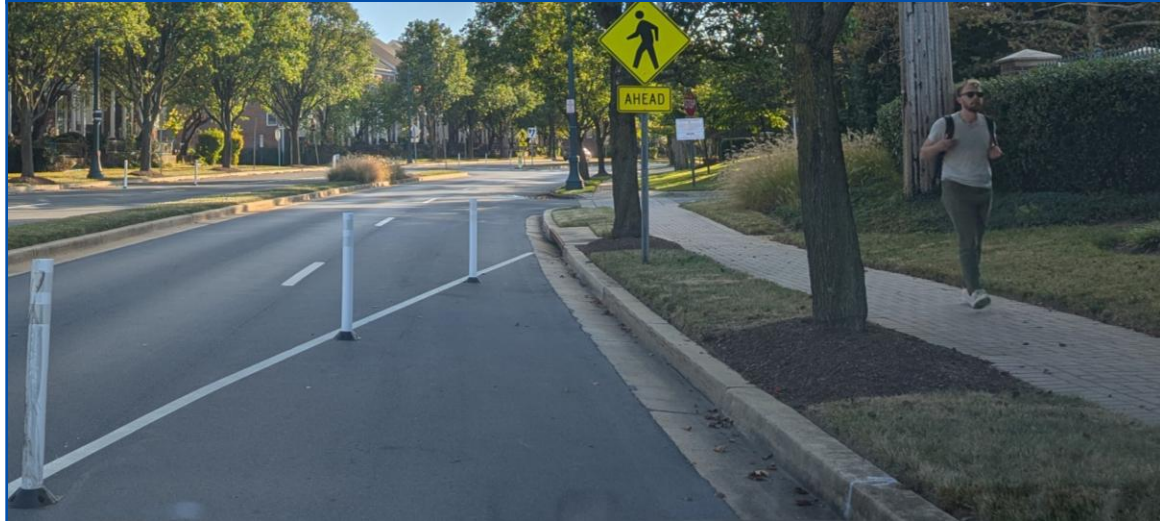

Redland Boulevard Demonstration Project

- Repurposed Outside Lanes
- Sept. 21 – Oct.17, 2025
- Findings
 - Reduction in speed citations and travel speeds
 - Underutilized on-street Parking
 - Traffic congestion
- Results shared with community
- Future pedestrian improvement evaluations

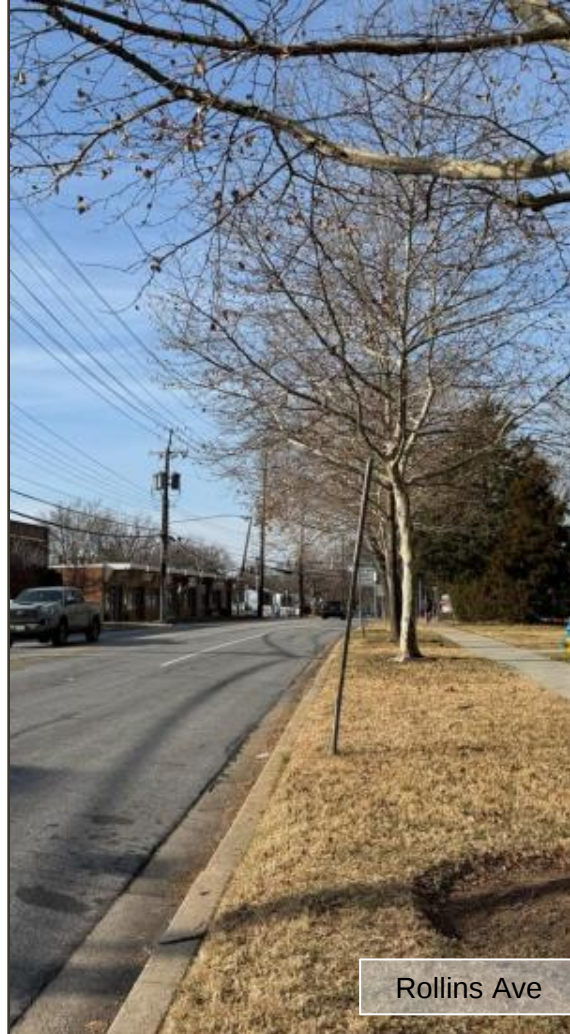

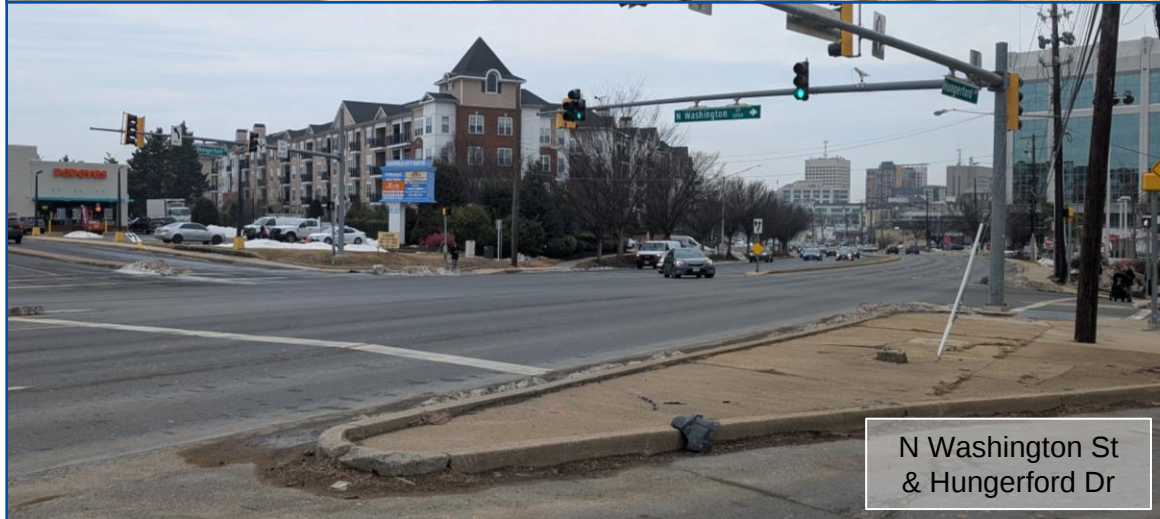
