- Fish responsibly in a way that will not compromise long term integrity of the fish stocks or habitat;
- Utilize the best available technology for selective harvest and low-impact fishing;
- Cooperate with other fishermen to avoid by catch and critical habitat;
- Comply with regulatory requirements for by catch, prohibited species, size limits, time and area closures, and reporting as required by all authorities including the International Pacific Halibut Commission;
- Operate vessels safely and professionally with an appropriate number of well trained and experienced crew in compliance with USCG regulations:
- Compensate crew in a fair and equitable manner;
- Recycle or safely dispose of used gear in an environmentally sound manner;
- Comply with regulations on discharge of oil, sewage, garbage and plastics
- Operate in a way that will minimize polluting effects or risk of inadvertent discharges;
- Cooperate with scientific researchers, fishery managers and enforcement authorities with regard to any ongoing programs;
- Maintain logbook data or other catch information.
