

**VILLAGE OF GLENCOE
RESOLUTION NO. R-XX-2026**

**A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF
A CONTRACT WITH MORENO LANDSCAPE AND HARDSCAPE FOR LANDSCAPE
MAINTENANCE SERVICES**

WHEREAS, the Village of Glencoe is a home rule municipal corporation pursuant to Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970 ("**Illinois Constitution**"); and

WHEREAS, Article VII, Section 10 of the Illinois Constitution authorizes the Village to contract with individuals, associations, and corporations in any manner not prohibited by law or ordinance; and

WHEREAS, the Village requires assistance with landscape maintenance services on municipal properties throughout the community ("**Project**"); and

WHEREAS, Village staff solicited bids for the Project from qualified contractors and received six responsive bids; and

WHEREAS, Moreno Landscape and Hardscape, of Highland Park, Illinois ("**Contractor**"), submitted the lowest responsive and responsible bid for the Project based on estimated hours provided by the Village in the amount of \$61,200.00; and

WHEREAS, the Contract includes a provision for two additional one-year extensions based on performance; and

WHEREAS, based on these factors, Village staff recommends entering into a contract between the Village and the Contractor for the Project in an amount not-to-exceed \$80,000.00 to account for seasonal variability in the Village's need for landscaping services ("**Contract**"); and

WHEREAS, the Village's Calendar Year 2026 Budget provides sufficient funds for the completion of the Project in Contractual Services / 100-300-210-50410; and

WHEREAS, the President and Board of Trustees have considered the Contract and determined that it is in the best interests of the Village and its residents to enter into the Contract;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF

TRUSTEES OF THE VILLAGE OF GLENCOE, COUNTY OF COOK, STATE OF ILLINOIS, as follows:

SECTION ONE: RECITALS. The foregoing recitals are incorporated in, and made a part of, this Resolution by this reference as findings of the Village Board of Trustees of the Village of Glencoe.

SECTION TWO: APPROVAL. The Contract is hereby approved in substantially the form attached as Exhibit A and in a final form acceptable to the Village Manager.

SECTION THREE: AUTHORIZATION. The Village Manager and Village Clerk are hereby authorized and directed to execute and seal, on behalf of the Village, the Contract only after receipt by the Village Clerk of at least three original copies of the Contract executed by the Contractor; provided, however, that if such copies of the Contract are not received by the Village Clerk within 60 days after the date of adoption of this Resolution, then this authority to execute and seal will, at the option of the President and Board of Trustees, be null and void.

SECTION FOUR: EFFECTIVE DATE. This Resolution will be in full force and effect from and after its passage and approval in the manner provided by law.
