I am writing on behalf of the Collinsville Historic Preservation Commission regarding your historic and architecturally significant property. You can be proud that your property is recognized as an important part of our city's architectural legacy.

As you may know, the City of Collinsville has a Historic Preservation Ordinance that established the City's Historic Preservation Commission and outlines the process for official City recognition of historic properties and districts. To recognize and protect those properties which represent the best from our past, the Commission nominates properties as Collinsville Landmarks, which are officially recognized by the City of Collinsville and the State of Illinois.
