**SUBJECT: RESOLUTION TO AMEND THE FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY ADDING AVAILABLE CIP PROJECT FUND RESERVES (RESTITUTION/SETTLEMENT FUNDS) TO “CITY FACILITIES - ROOF REPLACEMENTS AND REPAIRS” PROJECT**

## **RECOMMENDATION:**

It is recommended that the City Council adopt the following resolution:

**RESOLUTION NO. 2026-47 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO AMEND THE FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY APPROPRIATING \$140,000 OF AVAILABLE CIP PROJECT FUND RESERVES (RESTITUTION/SETTLEMENT FUNDS) TO “CITY FACILITIES - ROOF REPLACEMENTS AND REPAIRS,” FD428, CAPITAL IMPROVEMENT PROGRAM (CIP) | CC2590 CAPITAL IMPROVEMENT PROGRAM (CIP) | WORKTAG: PROJECT 71059**

## **EXECUTIVE SUMMARY:**

City Council adoption of Resolution No. 2026-47 (Attachment No. 1) will appropriate \$140,000 of available CIP Project Fund Reserves (Restitution/Settlement Funds) to provide additional funding for the “City Facilities - Roof Replacements and Repairs” to allow for the roof replacement at the Ralph Welch Park Community Center.

**FISCAL IMPACT:**

The Project was included in the adopted Capital Improvement Program (CIP) 2025-26 Budget. Approval of this action will add an additional \$140,000 of CIP Project Fund Reserves (Restitution/Settlement Funds) to the Project. **PREVIOUS RELATED ACTION:**

On May 6, 2019, the City Council created “City Facilities – Roof Replacements and Repairs,” Project No. 4285-2590-XXXXX-71059, to repair and/or replace the roof at multiple city facilities, to include community centers and public restroom buildings and appropriated \$1,188,000 in General Fund operational savings to the new Project.

On March 20, 2023, the City Council approved the revision to the Project description for “City Facilities – Roof Replacements and Repairs,” Project No. 4285-2590-XXXXX-71059 to include additional city facilities, while removing the Pomona Public Library from the description since it was being included in another CIP Project, “Pomona Library Facility Improvements.”

On July 1, 2024, City Council awarded a construction contract to AME Builders, Inc. in the amount of \$597,320 to provide for roof replacement at Palomares Park Community Center.

**DISCUSSION:**

The “City Facilities - Roof Replacements and Repairs,” FD428, Capital Improvement Program (CIP) | CC2590 Capital Improvement Program (CIP) | Worktag: Project 71059 provides for improvements for the repair or replacement of City facility roofs and related substructures or supports determined to be in most immediate need, based on condition, level of use in and around the facilities, and risk. During recent rainstorms, the roof at the Ralph Welch Park Community Center developed significant leaks that caused interior damage and temporarily forced a closure of the facility. This is the only actively programmed community center in this District. To prevent additional damage and allow the facility to reopen as soon as possible, Staff obtained three bids for the work through Omnia Partners, which is a cooperative purchasing platform. The lowest

responsive bid was received from Commercial Roofing Systems, Inc. in the amount of \$106,428. City Staff issued a Purchase Order to Commercial Roofing Systems, Inc. to begin repairs on the roof as soon as possible. In addition, Staff is appropriating sufficient funding to account for contingencies and required inspections.

**COUNCIL PRIORITIES & GOALS:**

***This item supports the 2021-22 City Council Priority 5: Goal O: Improve Parks facilities in the following general order of priority: 1) ensuring that existing amenities are functioning; 2) rehabilitating bathrooms and other park facilities and equipment; and 5) adding new bathrooms.***
