WHEREAS, PWFP is responsible for managing various extended services within CSA 1, CSA 15, CSA 23, and CSA 50, and;

WHEREAS, the annual revenue is currently insufficient to provide for the active services within CSA 15, CSA 23, and CSA 50, and;

WHEREAS, the annual revenue is currently insufficient to provide for the proposed expanded active services within CSA 1, and;

WHEREAS, a successful Proposition 218 election is required to bring annual revenue in line with annual costs for the active services, and;

WHEREAS, the CSA 1, CSA 15, and CSA 50 Advisory Committees voted unanimously to recommend the Board of Supervisors direct PWFP to proceed with the preparation of an Engineer's Report and complete a Proposition 218 election to increase direct benefit assessment rates to place annual revenue in line with annual costs, and;

WHEREAS, Board approval for preparation of the Engineer's Reports would allow for a Proposition 218 Election to proceed to increase the annual assessments within CSA 1, CSA 15, CSA 23, and CSA 50, and;

WHEREAS, these recommendations promote the County of Monterey Board of Supervisors Strategic Initiatives related to Administration, Health and Human Services, Infrastructure, and Public Safety. CSA Advisory Committees create a forum for open communication between County staff and property owners to ensure needs of the CSA community are met. Engineers' Reports with corresponding rate studies, if approved through subsequent Proposition 218 elections, will establish assessments that allow for effective administration of the CSAs; fund operations and maintenance of storm drains, open space, and streetlights; and provide enhanced public safety benefits to property owners and the public.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Supervisors of the County of Monterey hereby:

Adopts a resolution directing the Department of Public Works, Facilities and Parks to proceed with the preparation of an Engineer's Report and complete a Proposition 218 election for County Service Areas (CSAs) 1 – Carmel Point (CSA 1), 15 – Serra Village/Toro Park (CSA 15), 23 – Carmel Rancho (CSA 23), and 50 – Rioway Tract No. 2 (CSA 50) to increase direct benefit assessment rates to place annual revenue in line with annual costs for the active services (4/5th vote required).
