On April 8, 2026, the County of Westchester ("County") received and opened three (3) bids for Contract No. 25-512 for Rehabilitation of Westchester Avenue East Bridge over Mamaroneck River, (BIN 3358540), White Plains, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$2,846,241.75.

The low bidder has been investigated and it has been found that CRS Contractors Inc.:

Performed satisfactory work in the past for the County.

The objective of this contract is to improve the structural integrity of the Westchester Avenue Bridge over the Mamaroneck River.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring County bridges meet current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
