**ORDER ALTERING SPEED LIMITS
ON CERTAIN COUNTY ROADS**

ON the 30th day of May, 2025, after due notice as required by law, the Commissioners Court of Live Oak County, Texas, meeting in regular session, took up for consideration and action the following matter: Alteration of a Prima Facie Speed Limit on Certain County Roads.

WHEREFORE, State law provides, in §545.351 of the Texas Transportation Code that an operator may not drive at a speed greater than is reasonable and prudent under the circumstances then existing, and

WHEREAS, State law provides, in §545.355 of the Texas Transportation Code, authority for the Commissioners Courts of Texas to establish prima facie speed limits on roads outside of a municipality officially designated as a county road, and

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Hughes Circle is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Hughes Circle is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road Hughes Circle in Live Oak County, Texas, shall be 10 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Graves Ln is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Graves Ln is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road Graves Ln in Live Oak County, Texas, shall be 10 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Freeman Circle is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Freeman Circle is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road Freeman Circle in Live Oak County, Texas, shall be 10 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Vogelsang Ln is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Vogelsang Ln is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road Vogelsang Ln in Live Oak County, Texas, shall be 10 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Hidden Valley Dr is

currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Hidden Valley Dr is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road Hidden Valley Dr in Live Oak County, Texas, shall be 15 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Royal St is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Royal St is unreasonable and unsafe,

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road 320 is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road 320 is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road 320 in Live Oak County, Texas, shall be 45 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Airport Rd is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Airport Rd is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road Airport Rd in Live Oak County, Texas, shall be 45 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Dry Fork Rd is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Dry Fork Rd is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road Dry Fork Rd in Live Oak County, Texas, shall be 45 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road 312 is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road 312 is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road 312 in Live Oak County, Texas, shall be 45 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road 317 is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road 317 is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road 317 in Live Oak County, Texas, shall be 45 miles per hour.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road 151 is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road 151 is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road 151 in Live Oak County, Texas, shall be 25 miles per hour from FM 799 to Jones Rd

Cutoff, that will then be followed by the maximum prima facie reasonable and prudent speed limit of 40 miles per hour from Jones Rd cutoff for one quarter of a mile that will then be followed by the maximum prima facie reasonable and prudent speed limit of 45 miles per hour to Highway 281.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road Buckeye Knoll is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road Buckeye Knoll is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road Buckeye Knoll in Live Oak County, Texas, shall be 30 miles per hour from Jones Rd for one quarter of a mile, that will then be followed by the maximum prima facie reasonable and prudent speed limit of 20 miles per hour for another quarter mile, that will then be followed by the maximum prima facie reasonable and prudent speed limit of 10 miles per hour for the remainder of the road.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road North Shore is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road North Shore is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road North Shore in Live Oak County, Texas, shall be 45 miles per hour from FM 3024 to

County Road 344, that will then be followed by the maximum prima facie reasonable and prudent speed limit of 30 miles per hour to the end of North Shore Road.

WHEREAS, the Commissioners Court of Live Oak County, Texas, has determined that the prima facie speed limit on County Road 363 is currently 60 miles per hour based on its properties and the definitions found in §545.352, and

WHEREAS, the Commissioners Court of Live Oak County, Texas pursuant to that authority, finds that the prima facie speed limit for County Road 363 is unreasonable and unsafe,

IT IS THEREFORE ADJUDGED, DECREED AND ADJUDGED that the maximum prima facie reasonable and prudent speed limit on County Road 363 in Live Oak County, Texas, shall be 30 miles per hour for one half of a mile from FM 888, that will then be followed by the maximum prima facie reasonable and prudent speed limit of 45 miles per hour to FM 1040.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that signs reflecting these maximum prima facie reasonable and prudent speed limits shall be posted on appropriate county roads, and that such speed limits may be enforced by any and all law enforcement officers of the State of Texas in conformity with State law as a Class C misdemeanor, pursuant to §542.301, Texas Transportation Code. A person convicted of a violation of the speed limits imposed by this Order may be punished by a fine of not less than one dollar (\$1.00), and not more than two-hundred dollars (\$200.00), plus any costs of court pursuant to §542.401, Texas Transportation Code.
