B. County Service Area #1 (CSA1) Wilfred Tower Clean Up Proposal

County Service Area #1 (CSA1) is requesting expenditures of up to \$20,000 for cleanup of the Wilfred Radio Tower Site by the Long Valley Fire Protection District. Long Valley Fire Protection District is also requesting permission to use the tower to install their own radio equipment and power supply at their expense and responsibility to enhance emergency communications in their response area.

Recommended Action: Approve the County Service Area #1 (CSA1) request for expenditures of up to \$20,000 for cleanup of the Wilfred Radio Tower Site by the Long Valley Fire Protection District.

Fiscal Impact: CSA1 will fund the project up to \$20,000. If the cap is realized, then CSA1 will request additional expense to be paid from the CSA1 budget. Mono County will need to provide personnel to evaluate the operability of the equipment and determine which equipment needs to be removed. Personnel costs undetermined by CSA1.

H. Resolutions Amending the List of Allocated Positions and Approving an Agreement Regarding Terms and Conditions of Employment for County Surveyor

The Public Works Department has identified the need to establish a dedicated "County Surveyor" position to support the ongoing and future County infrastructure, land management, and development projects.

Traditionally, from 1861 until the retirement of Richard Boardman, the Mono County Surveyor was an in-house position. After the retirement of Richard Boardman, Mono County was unable to recruit an in-house County Surveyor and was required to contract out some of the County Surveyor duties.

Designating Sean Robison as Mono County Surveyor, will once again bring the position back to Mono County and eliminate the need for contract County Surveyor services.

Recommended Action: (1) Adopt proposed resolution adding one Surveyor position to the allocation list in the Public Works Department; and (2) Announce Fiscal Impact. Adopt proposed resolution approving agreement regarding the terms and conditions of employment for Sean Robinson to the position of County Surveyor, and prescribing the compensation, appointment and conditions of said employment. Authorize the Board Chair to execute said resolution and agreement on behalf of the County.

Fiscal Impact: The estimated cost of this position for the remainder of the fiscal year is \$42,573, of which \$33,796 is salary and \$8,777 is benefits. The total cost of salary and benefits for an entire fiscal year is \$179,084, of which \$142,165 is salary and \$36,919 is benefits. This is included in the Public Works fiscal year 2026/2027 adopted budget. Salary costs will be offset by the reduction of as-needed survey and contract County Surveyor consultant services.
