MSU Extension 2021 Annual Report

Interim District 4 Director Julie Darnton appeared to present the MSU Extension Annual Report. Ms. Darnton has worked for MSU Extension for 15 years and is now the Interim District Director for MSUE’s District 4 which covers Alcona, Arenac, Crawford, Iosco, Ogemaw, Oscoda and Roscommon counties. MSU Extension did not foresee the impact of the global pandemic and losses so devastating. Within six days of the first Stay Home order, MSU Extension launched the Remote Learning and Resources website, and teams modified programs to engage families, communities, business owners, and leaders to keep moving forward. Nicole Wethington, Program Instructor Disease Prevention Management/Social Emotional Health Provided hosted 28 programs, reaching 581 participants across the state, including 137 Crawford County residents. 4-H Program Coordinator Angela Cook collaborated with 4-H Program coordinators to provide online youth programs focused on safety first. Ms. Darnton introduced Sarah Peterson the County Nutrition Instructor and Support Staff member Jamie Greer.
