B. Parcel Map(s) for Review and Recommendation of Approval to County Surveyor

i. **Project Title:** Fox Hill (Mitchell) PM - ESD25-00302

Project Location: Minor Land Division to subdivide approximately 36 acres into 3 parcels. The project site is in Newcastle, northwest of the intersection of Uncle Joe's Lane and Ridge Road. Lots will be developed with individual driveways connecting to Fox Hill Lane.

ii. **Project Title: 1.** Ice Lakes Lodge (Tucker) PM - ESD25-00299

Project Location: Minor Land Division in the Tahoe area, to subdivide one parcel into two. Parcel 1 has an existing building to be divided into four residential condominium units. Parcel 2 is intended to be developed with a single-family residence. Parcel 2 is bifurcated by a roadway creating parcel areas 2a and 2b. Parcels are accessed off Soda Springs Road.

i. **Project Title:** The Ranch LLFM - ESD24-00044

Project Location: The Ranch Large Lot Final Map encompasses approximately 222 acres on the south side of Vineyard Road, east of Cook Riolo Road, in the West Placer area. This LLFM will create 13 large lots for phased development of the proposed project. The 13 large lots include 1 existing developed single-family lot, 7 large residential lots, 3 open space lots, and 2 school lots. This Map has no development rights and will not include any building permits.
