D. Third Quarter Budget Update and Appropriation Requests

The 3rd Quarter budget update for Fiscal Year 2025–26 will be presented to the Board by the Budget Officer, Dani Varela. This update includes multiple departmental Appropriation Transfer Requests and Position Allocation Requests.

Recommended Action: Receive the Quarter 3 budget update and approve, by a 4/5 vote, the requested Appropriation Transfer Requests and Position Allocation Requests. Additionally, staff recommends appropriating \$500,000 of these vacancy savings to Contingency, with the remaining \$2.5 million retained in fund balance as a prudent fiscal safeguard. In light of the recently approved \$1.5 million in expenditures for the Pack Fire.

Fiscal Impact: The Quarter 3 (Q3) budget adjustment reflects an increase of \$1,652,500 in revenues and a decrease of \$3,595,829 in expenditures. Of the revenue increase, \$900,000 is attributable to the General Fund, while \$3,065,747 of the expenditure reduction is within the General Fund. Additionally, as of the end of Q3, the County has realized \$5,059,248 in vacancy savings, of which \$3,029,297 is from the General Fund.

E. Enterprise Resource Planning (ERP) Project Update and Funding Decision

Mono County’s current reliance on the Harris CitySuite system no longer supports the County’s operational, reporting, or integration requirements, resulting in fragmented processes, manual workarounds, and inconsistent practices across departments. The lack of system integration increases the risk of errors, adds administrative burden, and limits the County’s ability to produce timely and accurate financial and compliance reporting. Core functions including accounting, procurement, HR, payroll, and asset management remain decentralized and inefficient due to significant process gaps and outdated workflows. While the County previously explored a full ERP implementation with support from GFOA, the current recommendation proposes a more measured, phased approach that addresses immediate deficiencies while allowing additional functionality to be added as resources become available.

Recommended Action: Board approval is requested to move forward with the recommended Enterprise Resource Planning (ERP) solution. Approval will authorize staff to prepare and publish an RFP, negotiate a contract with the selected vendor, finalize implementation planning, and proceed with the selected vendor as outlined in the accompanying staff report.

Fiscal Impact: \$1,800,000 from a hold of contributions to the Pension and OPEB trust funds, which have seen high investment earnings over the last two years.
