

# Town of Parkton Board of Commissioners

## Meeting Minutes for January 7, 2025

Mayor Underwood called to order the Meeting of the Board of Commissioners at 7:00 pm on January 7, 2025. The following members of the Board of Commissioners were present: Mayor Underwood, Commissioners Carlson, Lowery, Mahaffey, and McColl. Commissioner McVickers was absent. Commissioner McColl gave the invocation. Mayor Underwood led the Pledge of Allegiance.

### **Approval of Minutes**

Mayor Underwood called for approval of the Minutes from December 3, 2024. Commissioner Carlson made a motion to approve the agenda. Commissioner Lowery seconded and the Motion carried.

### **Approval of Consent Agenda**

Mayor Underwood called for approval of the Consent Agenda items. Commissioner Mahaffey made a motion to approve, Commissioner Carlson seconded and the Motion carried.

### **Extraterritorial Jurisdiction**

Attorney is waiting on information to proceed from Tom Lloyd who will give information to another attorney for her to follow up with.

### **Citizen Comments**

**Brandon Williams** - Will there be movement from the city with waterlines, ditches Squire has made it a nightmare for them, they are not attempting to do anything to help the homeowners. Attorney explained that this is a private matter between the homeowner and the developer so the Town cannot get involved.

**Robin Merkel** – Volunteer coordinator for Meals on Wheels, asked for volunteers and also if anyone knows anyone who could use the service, please contact Town Hall and let them know and they will pass on the information.

### **Public Works**

**Utility Clerk** – Joe meeting with the State re well 4 to see if we can get movement on that. 2 service breaks were repaired within 6 hours. 5 new accounts, 2 new homes and 3 rentals.

**Police** – 2 alarm responses 1 disorderly conduct calls, 2 requests to speak with an officer, 1 disturbance call, 1 breaking and entering, 1 request from another agency to assist, 1 weapons violation call, 1 change in mental status call, and 1 health and welfare report. There were 6 traffic stops – 1 running of a red light, 1 improper vehicle tags and 4 speeding.

**Admin** – Received the second Powell bill allocation for the year, reflected in the new account balances. Provided information on budget to date info for the water sewer dept for future discussion.

**Legal** – Review of her records for the last year and questions that have been asked.
