



THIS AMENDMENT TO AGREEMENT NMC-VIZLMS-2022 (the “Amendment”) is made and entered effective the 1st day of May 2025 (“Effective Date”), by and between **NATIVIDAD MEDICAL CENTER** (“Client”), and **HPC International, Inc.**, an Illinois corporation with its principal office located at 5261-A Fountain Drive, Crown Point, IN 46307 (“Supplier” or “HPC”). Client and HPC are sometimes referred to herein individually as a “Party” and collectively as “the Parties”.

WHEREAS, the Parties entered into the HPC Supplier Master Service Agreement **NMC-VIZLMS-2022** executed and made effective on June 15, 2022 (as may be amended from time-to-time, the “Agreement”); and

WHEREAS, the Parties desire to amend the Agreement pursuant to the terms, conditions and provisions set forth in this Amendment.

Defined Terms. All capitalized terms used in this Amendment shall have the same meanings given such terms in the Agreement, unless otherwise defined in this Amendment, and all terms defined in this Amendment and not defined in the Agreement are hereby incorporated into the Agreement for all pertinent purposes.

Client and Supplier each represent and warrant to the other that the person signing this Amendment on its respective behalf has the requisite authority and power to do so, and to thereby bind the Party on whose behalf such person is signing.

This Amendment may be executed in a number of identical counterparts which, taken together, shall constitute collectively one Agreement.

Except as herein expressly modified, all terms and conditions of the original Master Service Agreement shall remain in full force and effect. To the extent of any inconsistency between the terms and conditions of the Agreement and those of this Amendment, the terms and conditions of this Amendment shall govern.

1. This Agreement and the Initial Term of this Agreement as described in Section 1. (A) is hereby extended, with a new expiration date of **June 30, 2025**.
2. Exhibit B (Exhibit B-1) will hereby be updated with the added cost of the dates not covered under the Agreement. The added service fee costs associated with this amendment total **\$2,384.62**, as described below in Exhibit B.

The Parties acting in good faith are in full and complete agreement on all terms contained within this Amendment and have carefully reviewed each section of the Agreement in its entirety.
